



Monetization of **USD 220 Mn+** block held by an offshore institutional investor ahead of IPO through secondary sale to domestic institutional investors.

The client was an offshore Asia-based institutional investor seeking a partial monetization of its holding in a tech based hyperlocal food delivery entity, ahead of public listing.

We created required liquidity for the offshore institutional investor in record time of 4 weeks by garnering 2.5X subscription for proposed block. Secured optimum pricing for buy side investors with sizable arbitrage potential for downside exit.

Facilitated both Buy & Sell side with market intelligence, price discovery, documentation closure, obtaining third-party Tax and Valuation opinions, coordinating cross-currency remittances and documentation support in RBI/FEMA compliances.





Demand of USD 9 Mn+ of Anchor investors through QIBs and USD 4 Mn+ pre-IPO was met with a mix of Institutional investors and HNIs.

The client is a leading Indian manufacturer of tractors, cranes, and other agricultural machinery exporting to **20+ countries** across Europe, Asia and Africa.



We helped them with finding the right set of investors for pre-IPO earmarked for a plant setup, keeping a good tenure engagement and industry mapping in mind.

This required a consultative approach for investor onboarding which was executed seamlessly, inviting anchor book handling request from BRLM which they usually handle.

The turn around was ~3 months for pre-IPO and ~1.5 months for meeting Anchor investor demand.
